As grounds for its Notice of Intervention, NYSDEC respectfully asserts:

- 1. NYSDEC is a duly constituted Department of the Government of the State of New York, charged by law with administrative management of the State's fish, wildlife, water, and other natural resources.
- 2. The project is located within the State of New York and impacts the natural resources and environment of the State of New York.
- 3. As the agency of the State of New York responsible for administering New York State's Environmental Conservation Law, Petitioner is the State agency most intimately involved with and responsible for analyzing environmental impacts of hydroelectric projects. Petitioner's resources, expertise, and familiarly with the locale of the proposed project and related resources will be of considerable assistance to the Commission during the course of the above-captioned proceeding.
- 4. NYSDEC is a State agency charged by law to consider and, upon proper showing, issue water quality certifications for hydroelectric facilities pursuant to Clean Water Act § 401, 33 USC § 1341.
- 5. Petitioner's participation as an agency of the Executive Branch of the State of New York government is in the public interest, as well as in the interest of the public health, welfare, and the environment.

- 6. Granting NYSDEC party status will not disrupt the proceeding.
- 7. NYSDEC's interest is not adequately represented by any other party hereto.
- 8. Existing parties will not be prejudiced by, nor will they sustain any additional burden by NYSDEC becoming a party to this proceeding.

WHEREFORE, Petitioner respectfully requests that the Federal Energy Regulatory Commission grant NYSDEC intervention as a fully party in this proceeding. NYSDEC does not request a hearing in this proceeding at this time; however, if a hearing is ordered, NYSDEC further requests that it be granted the right to have notice of and an opportunity to appear at all hearings in this proceeding, to produce evidence and witnesses, to cross-examine witnesses, and to be heard by counsel or other representatives for briefing and oral argument if oral argument is granted.
