Dear Mr. Myers:

Your March 19, 2024, letter submitted an external audit plan for Eagle Creek Renewable Energy (ECRE) affiliates. Attachment I of this letter includes the list of dams and ECRE affiliate companies. 18 CFR §12.65 requires that your ODSP undergo an external audit every five years. The last audit was completed in 2019.

Our Annual Reminder Letter¹ requires you to submit a statement of qualifications of the proposed auditor for our review and acceptance. The plan proposes a team consisting of two auditors, a project engineer/note taker, a project manager, and a senior reviewer. Resumes of the proposed team members are provided, and the team is acceptable. In additional to reviewing the current ODSP, the team plans to visit multiple projects in each region to perform site visits and interviews. The plan provides a schedule of key milestones, with a due date by **October 31, 2024** for the final report. The audit plan and schedule were reviewed and are acceptable.
