Dear Mr. Drew,

On October 29, 2024, we issued an environmental assessment for the relicensing of the Christine Falls Hydroelectric Project No. 4639 (Christine Falls Project).¹ In a letter issued that same day, we informed the U.S. Department of the Interior (Interior) of our preliminary determination that three of its recommended fish and wildlife measures, made pursuant to section 10(j) of the Federal Power Act (FPA), may be inconsistent with the public interest and comprehensive development standard of sections 4(e) and 10(a) of the FPA. In a letter filed December 13, 2024, Interior's U.S. Fish and Wildlife Service (FWS) requested a 10(j) meeting to discuss its recommendations.

Section 4.34(e)(4) of the Commission's regulations requires that any meeting take place within 90 days of the date the Commission issues a preliminary determination of inconsistency. We will hold the section 10(j) meeting with FWS on Wednesday January 22, 2025, at 10:00 a.m. Eastern Standard Time. The meeting will be held via teleconference. An agenda for the meeting is attached to this letter.
